

The 2019 World Singles Champion of Champions was held October 28 - November 3 at Adelaide Lawn Bowling Club in Adelaide, Australia. The coveted event featured 45 international players competing for two world singles titles.

The United States was represented by Charlie Herbert and Sandy Wall. To qualify, each competitor must be the National Singles Champion from his/her country.

Each division was divided into two sections for a Round Robin format. A game consisted of 2 Sets - nine ends each - the winner having won both sets. If a tie occurred, then 3 additional ends were played to determine the winner.

Charlie made it to the playoffs - losing a close game against England's Louis Ridout. Out of the 25 male competitors, Charlie finished in 6th place. Sandy finished 16th out of 20th. Both Charlie and Sandy "feel so honored to have represented the United States in such a prestigious event."

A special thanks go to Cindy Higgins for attending the event in the capacity of Sandy's coach.

2019 WORLD JUNIOR UNDER 25 CHAMPIONSHIPS

(Includes Men's and Ladies Singles & Mixed Pairs Indoor Events)

VENUE: WEST DENTON IBC, NEWCASTLE - UPON-TYNE, ENGLAND, UK

December 2019

To: All Member National Authorities of World Bowls & The International Indoor Bowls Council

The 2019 World Junior Under 25 Championships will be hosted by West Denton Indoor Bowls Club, Newcastle-Upon-Tyne, England, U.K. These annual INDOOR championships feature Men's and Ladies Singles and Mixed Pairs events. Member National Authorities are now invited to exhibit their full support for these events by completing and returning the attached "confirmation of entry" form as soon as possible, for the 2019 World Junior Under 25 Championships.

Please Note: the final date of 14th June 2019 for receipt of this completed form.

Event Dates

The playing dates for the 2019 World Junior Under 25 Championships to be staged at West Denton IBC, Newcastle-Upon-Tyne, England, U.K. have been agreed as being Tuesday 3rd December to Friday 6th December 2019. The official arrival date for U.K. based players will be 2nd December and the official departure date will be 6th December, the arrival date for overseas players will be 1st December and the departure date the 7th December. The official practice day will be on Monday 2nd December and the players meeting and opening function will also be held on this day.

Age Eligibility

Entrants must have not reached their 25th birthday by the start of the event.

Structure of the Event

The championships will consist of Men's and Ladies Singles and Mixed Pairs events.

Where a Member National Authority submits both a male and female entrant, those entrants will be paired together to play in the Mixed Pairs event.

Where a Member National Authority is only able to submit a male entrant or a female entrant the International Indoor Bowls Council will make every effort to pair that entrant with another entrant of the opposite gender from another entering country so that all entrants have the opportunity to play in both the Singles and Mixed Pairs events.

National Member Authorities entering both a male and female competitor shall have the option to enter a second male and female competitor. The second entry must be for both a male and female competitor. Please see email accompanying this document regarding those Member Nations in the UK with separate indoor and outdoor national authorities.

All events will be played in sections with the number of sections subject to the final level of entries and finals rounds will be played in knockout format.

Playing Formats

Singles: 4 bowls each player, 2 sets of 7 ends each set, with a 1 end tie break in the group stages and 9

ends with a 1 end tie break in the knockout stages.

Mixed Pairs: 2 bowls each player, 2 sets of 7 ends each set, with a 1 end tie break in the group stages and 9

ends with a 1 end tie break in the knockout stages.

No dead ends: the jack will be re-spotted at the central 2 metre spot

Other Matters

Accommodation will be organised by the International Indoor Bowls Council. Competitors will be required to share a twin room with another competitor of the same gender and culture. World Bowls will be financially responsible for accommodation of competitors between the agreed official arrival date and the agreed official departure date only. The International Indoor Bowls Council will provide lunch at the club during the period of the event.

Member Authorities sending a coach or coaches to accompany their selected competitors must register their details with the International Indoor Bowls Council prior to the start of the event and shall be financially responsible for all costs of these officials.

Member Authorities sending Presidents or other Officers shall also be financially responsible for all costs of these officials.

All competitors to wear National Uniform during play and ceremonies.

National Flag and National Anthem on CD to be supplied to the Tournament Director upon arrival.

Flight details to be provided to David Phillips as soon as possible.

Please note that any withdrawals later than 30 days prior to commencement of the event will be subject to a £250 late withdrawal fine, invoiced to the National Authority along with any other relevant costs incurred as a result of late withdrawal.
